

## **VISA APPLICATION INSTRUCTIONS**

In order to avoid delays, it is absolutely essential for all applicants to answer all the questions and to adhere to all of the following: (note: the embassy is not obligated to inform the applicant if any of the requirements are not met. Your application and passport will be placed in the pending box or returned to you if a prepaid envelope was enclosed.) Visa hours are from 9:30a.m. to 12:30 p.m. Rush pick-ups are from 3:00pm to 4:00pm winter time and 4:00 to 5:00pm summer time. For same day processing a Rush Fee of \$50.00 in addition to the visa fee is required and a Fee of \$40.00 for next day processing in addition to the visa fee.

- Before sending your individual application and passport, please ensure that your passport is valid for at least six (6) months and that there are sufficient blank visa pages in it marked with the words "VISA" or "ENTRIES". Please allow three (3) to five (5) business days for visa processing.
- 2) Application forms must be submitted in two (2) for each applicant together with two latest passport sized photographs. Please append your signature on the back of each photograph and staple one photo to each application form. Photocopies of application forms will be accepted. U.S. Applicants below the age of 16 years do not need visas but they do need passports as all travelers do.
- 3) Clients traveling on business contracts, seminars, church business or study-related trips should submit their applications with either a cover letter or copy of work permit from their authorizing sponsor or prospective employers specifying in brief detail the nature of their intended business trans actions in Zambia. A Business Visitor is entitled to thirty- (30) days visit in a period of twelve (12) months. Travel Itinerary or copy of your air ticket should be attached.

## 4) Commonwealth Countries

I. Members of the Commonwealth countries listed below; and depending on reciprocity from countries such as Ireland, Romania and Yugoslavia are exempted from applying for visas to Zambia except when traveling for business (please refer to number 3 above)

- **6) Procedure:** All applicants falling under category (5) above, are required to complete the following steps:
  - I. Make copies of the relevant pages of your passport;
  - II. Complete a Visa application form;
  - III. Include a cover letter stating your reasons for traveling to Zambia and itinerary;
  - IV. Applications must be submitted at least one month before date of travel, together with a letter from host and the requirements listed in (2) above.
  - V. Send all of the above documents to Chief Immigration Officer, P. O. Box 50300 Lusaka, Zambia. Fax to 260-1-251725 or Email: <u>immighq@zamnet.zm</u> or Tel: (260-1) 252622/ 252659/252650.
    - Note that Visa approval is sent to the Embassy of Zambia in Washington, DC.

- Follow-up with the DC office should be made at least 2 weeks after you submitted your application. Once approval is communicated, send your documentation to the Washington DC office for processing.
- In addition to the appropriate Visa fee, you are required to add \$5.00 for administrative costs.
- U.S. PASSPORT HOLDERS ONLY: A Multiple Entry Visa valid for 3 years is issued for a processing fee of \$100.00 effective July 18, 2005. Diplomatic and Official Visas, valid for 3 years are Gratis. Note that only a multiple entry visa is issued.
- 8) FOR BRITISH PASSPORT HOLDERS ONLY: A Single Entry Visa valid for 6 months – US\$60.00. A Multiple Entry Visa valid for six (6) months – US\$80.00.
- 9) FOR SCANDINAVIAN PASSPORT HOLDERS ONLY: Norway, Sweden and Finland nationals shall be issued with Gratis visas at Missions or Port of Entry. The visas are multiple and valid for six (6) months. Denmark – Gratis Visa to be issued at Mission before travel.
- 10) Visa processing fees/validity for most nationals EXCEPT U.S., British and Scandinavian Nationals are as follows:
   \$25.00 for Single Entry Visa Valid for (6) months;

- \$40.00 for Double Entry Visa Valid for (6) months; \$80.00 for Multiple Entry Visa Valid for (6) months
- 11) Fees must be paid in CASH, MONEY ORDERS or BANK CERTIFIED CHEQUES ONLY. No personal or company checks will be accepted. Fees are payable to the Embassy of the Republic of Zambia.
- 12) Applicants who wish to have their passports mailed to them after processing should include their own pre-paid envelope (USPS Express/FedEx/UPS/DHL) ONLY. Ordinary Mail, Registered, Certified and Priority are not accepted.
  - 13) For precautionary measures, travelers to Zambia are advised to be immunized against Yellow Fever prior to their journey. This is compulsory for people traveling from yellow fever-infected countries. It's recommended that anti-Malaria course tablets commencing two weeks before travel is strongly advised.
